15 AMP HIGH DENSITY SLIM POWER STRIP



INSTALLATION

TIP: The provided wood screws allows the mounting clip to be installed to a wood surface. Additional holes provided for a #6 and #8 wood screw.

- 1) Using the provided hardware, secure the clip to the rackrail mounting bracket. Align the clip vertically using a straight edge. (FIGURE A).
- 2) Align the power strip with mounting clip and snap into place.

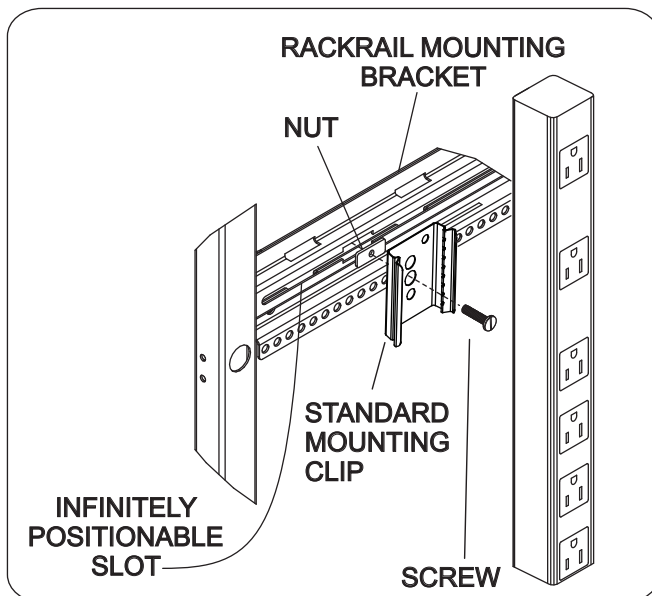
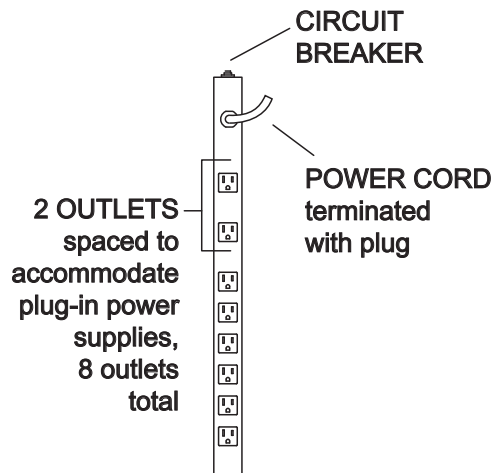
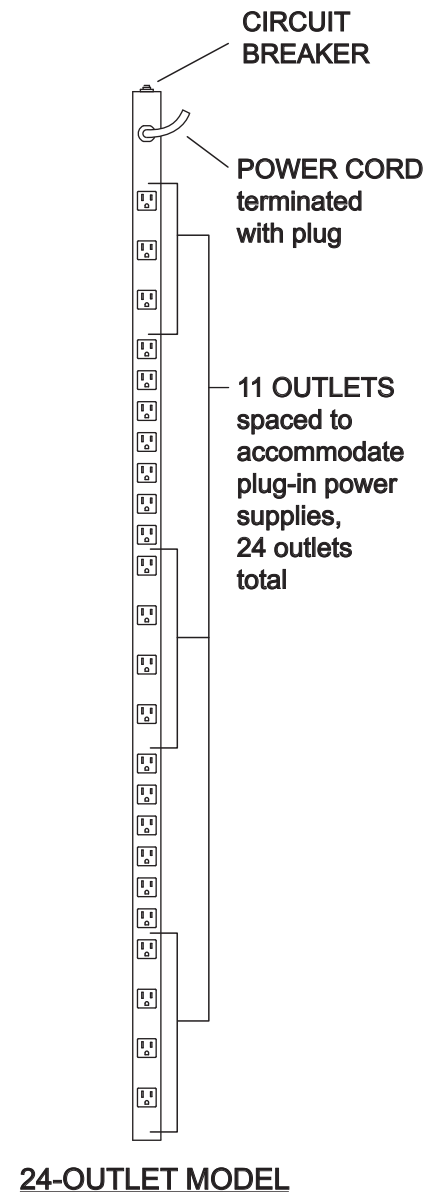

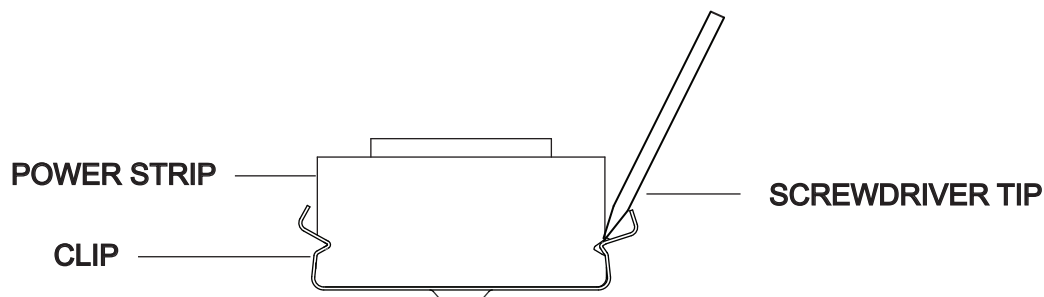


8-OUTLET MODEL

TIP: To remove the power strip from the mounting clips, wedge a flat tip screwdriver between side of power strip and clip, gently prying the power strip from the clip.
